20-Year Limited Residential Warranty / 3-Year Limited Commercial Warranty

Keter warranties to the original purchaser that, for a period of (20) years of residential use or (3) years of commercial use from the date or purchase, under normal usage conditions, Keter Adirondack models (KA-100, KA-200, KA-300, KA-400, KA-401, KA-402), otherwise referred to as ("the Product") will be free from manufacturing and material defects when subject to proper use and will not crack, splinter, chip, peel, rot, or suffer structural damage from insect infestation. Your Keter "Made in the USA" Adirondack was hand-crafted using the highest quality virgin and recycled High-Density Polyethylene (HDPE) materials, the gold standard in plastic.

- Industry-leading mortise and tenon construction and stainless-steel hardware
- Color-through construction and textured appearance to emulate the authentic look of hardwood
- UV-enhanced materials to prevent fading (includes exclusive 2-year fade warranty for peace of mind) however, upon sun exposure all colors will fade, to some degree, over time. Keter, at its sole discretion, will determine if fade is beyond normal and replace the abnormally faded part or product.
- Virtually maintenance-free materials that don't require staining or painting—and require minimal upkeep (furniture should be cleaned regularly—and depending on region can get surface mold)
- Manufactured using a proprietary blend of virgin and eco-friendly recycled material to help keep our planet and environment clean

Exclusions

Assembly and handling not in accordance with the recommendations, guidelines and restrictions as described in the assembly instructions will void this warranty. Keter is not responsible for any damage incurred by third parties or damage to or loss of objects inside or near the product.

Upon submitting proof of purchase and evidence of the claimed product failure, and subject to reporting the failure in a timely manner, Keter, at its sole discretion, will replace defective parts of the Product, or refund you a prorated portion of the purchase price on a straight-line depreciated basis for the length of the warranty.
